



## ARTWORK REQUIREMENTS

### Acceptable File Formats

- Native files are **preferred**. Adobe CC - Illustrator (.ai, .eps), InDesign (.indd), Photoshop (.psd, .tiff)
- Hi-Res Pdf's are acceptable (with 0.5" bleed, all fonts outlined or packaged, and all image links included)
- Submit a final file for each individual graphic panel (**do not** place multiple panels artwork in one file or gang artwork)
- Shop or specification drawings cannot be used for final artwork submission. Full-sized artwork must be provided to avoid delays with the order.

### Fonts

- Convert all fonts in artwork, including all image links, to outlines or provide all font files.
- **NOTE:** outlined or rasterized text cannot be altered.

### Color Reference

- Convert all files to **CMYK** color profile. Leave all Pantone colors as spot colors.
- Pantone Solid Coated colors preferred for color reference.
- Any additional color matches requested must include a physical sample provided by the customer.

### Panel Layout

- **Bleed:** include a minimum of **0.5" bleed** in panel artwork. "Bleed" includes images and/or background colors that are extended beyond the cutline.
- **Edge Borders:** outside borders must have minimum of **0.5" width**.
- **Live Area:** text, photos, drops shadows, or any elements that are not intended to be bleeding off the sides should be placed a minimum of 0.5" from edge of the panel.
- **Vector Cutline and Hole Locations:** must be provided on a separate layer in the file.
- **Placed Images:** include ALL photos, scans, logos, etc. in a separate folder. If image links have fonts, they must be converted to outlines, or font files included.
- **Image Quality:** Images need to be at **150 dpi** minimum at **100% full size**.
- **Indexing:** indicate in the artwork where the image should be indexed, seamed or tiled. Try to avoid placing seams that go through text or images. Refer to our [indexing document](#) for more information.
- **Double Sided:** refer to our [double sided document](#) for more information
- **Maximum panel size: 58.5" w x 144" h**, fastest lead time 48.5" w x 144" h, larger panels will require additional lead time. [Contact your sales representative](#) for more information.



## File Submittal Package

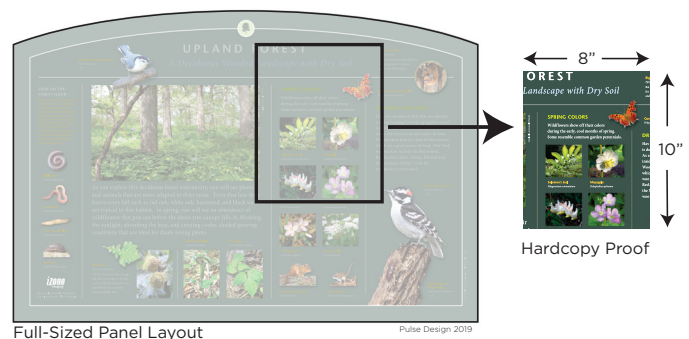
- Create a folder and name it your iZone Imaging job number and project name.  
**Include in the folder: ALL** production files, image links and font files, if they have not been converted to outlines.
- Zip/Stuff the folder into a compressed folder before uploading - **DO NOT** upload individual files.
- **Shop drawings:** include drawings that will clarify any and all hole sizes and locations, special cuts, bevels, or relevant elevation/mural dimensions of the area. Shop or specification drawings **cannot** be used for final artwork submission.
- Include a low-resolution PDF of the file for proofing purposes.

## Upload Files to iZone FTP site

- Log in to the iZone Imaging FTP site by using the [Upload Files](#) link at the top of our home page.  
--> User name: **ftpuser**  
--> Password: **uploadme**
- Complete **ALL** fields listed on the form, including iZone Quote/Order #.
- You can either click on **Choose Files By Selecting** or drag and drop your files into the box to attach files for upload.
- Once you have completed all of the fields and selected your files, click on **Begin Upload**.
- An automated notification is then generated by the system that sends an e-mail to iZone Imaging. We highly recommend that you contact your Sales Representative to notify them that you have sent files using our FTP site.

## CHPL Color Samples

- Color samples consist of an 8" x 10" cropped section of the full-sized panel layouts.
- Each color sample is pressed in 1/16" CHPL material and has the same finish as the final product.
